## **Petition Against The Closing of The Menands Village Court**

To Mayor Marsh and The Menands Village Board:

During the Special Meeting of The Menands Village Board held on Wednesday, February 12, 2025, at 5 PM the Menands Village Board Voted 4 in favor and 1 against closing the Menands Village Court. During the meeting comments were heard by Village Residents.

During the meeting the resident were advised of the following rules for a Permissive Referendum:

1. There must be 20% of the residents who were registered voter during the last Village Election which is 608 residents must sign the petition.
2. Only registered voters of the Village may sign the petition.
3. A valid petition must be filed with the Village Clerk within 30 days of the passage of the resolution on February 12, 2025.
4. If no petition is filed within 30 days, the resolution adopted by the Village Board of Trustees takes effect by operational law.
5. The Petition must be on white paper
6. Consecutive numbered at the foot of each page
7. Contain the full name, address of each induvial who signs the petition with the date when signed.
8. The Village Clerk must verify that signatures on the petition are truly registered voter of the Village.
9. If the proper numbers of signatures are met the Permissive Referendum will be voted on during the Village Elections held on June 17, 2025, from 12 PM and 9 PM.
